



Conditions of Entry and Retention of a Place

- Students must abide by the rules and guidelines involved in school life at the School.
- The School reserves the right to discipline, suspend or expel any student whose attitude or behaviour does not meet the expectations of the School.
- Parents will co-operate with the School in matters of discipline, attendance, completion of homework and assignments and the wearing of School uniform.
- As is usual in an Independent School, full parental support is essential to the successful progress of students through the School.
- All students must attend and participate in Christian Studies classes, Chapel Services and overnight camps.
- I/We understand that the only religious adornments, symbols or practices that are allowed are those of the Christian faith. The sole arbiter of matters of this nature is the School Principal.
- I/We understand that the Enrolment Acceptance Fee is non-refundable and that the Family Bond (where applicable) will only be refunded when all outstanding fees and charges have been paid in full or at the discretion of the Principal.
- I/We understand that continued enrolment at the School is dependent on the payment by Parent/Carer(s) of all Fees, Charges and Expenses in a timely manner by the due date set out in notices.
- I/We understand that school fees and charges must be paid by direct debit from a credit card or bank account.
- ONE FULL TERM'S WRITTEN NOTICE, or within 30 days of the date on which a notice of a Fee Increase is given, advising the impending withdrawal of a student from the School is required. In the event that such written notice is not given, then the equivalent of one term's fees in lieu of that notice will be charged to you in addition to any other fees or charges still unpaid. Except as provided in this clause, school holiday time does not form part of the notice period. This represents a reasonable estimate of the loss that will be suffered by the School if parents have not provided notice in accordance with these Terms and Conditions.
- Families new to GRG are required to submit a Direct Debit form for payment of Fees.
- In the event of Georges River Grammar School Ltd being required to engage a Debt Collection Agency to recover outstanding monies, all recovery costs incurred will be passed on to the families involved via their fee account.
- I/We understand that at Georges River Grammar students are expected to and are encouraged to maintain and protect our school community by:
 - Having consideration for others by not engaging in bullying or harassment of others.
 - Following all policies as documented in the Student Diary
 - Respecting the Christian ethos and purpose of the School.
 - Accepting the determinations of the Principal with respect to all of the above.
- It is expected that all relevant information regarding your child and their education be given to the School. Should the School become aware that all information has not been disclosed then the enrolment may become void.
